For Immediate Release – Friday, January 6, 2023

On Thursday, December 22, 2022, The Oneida County Sheriff's Office received information that a female was dropped off at St. Mary's Hospital in Rhinelander. The female subject stated that she had been held captive, tied to a chair, strangled with a belt, and beaten at a residence in the Town of Pine Lake, Oneida County.
